Minutes of the 3rd Business Meeting of the ICOS Working Group on Toponymy New York, 1st May 2025

The ICOS Working Group on Toponymy met on May 1st, 2025, 13.15-14.30, during the 4th (new) UNGEGN Session in UN facilities nearby the UN Headquarter, New York, USA. The meeting had 8 participants: Andrea Bölcskei (Hungary), Osward Chanda Penda (South Africa), Sungjae Choo (Republic of Korea), Matjaž Geršič (Slovenia), Tiina Laansalu (Estonia), Kohei Watanabe (Japan), Maciej Zych (Poland), and Peter Jordan (Austria). The Working Group's Chair, Peter Jordan, chaired the meeting and led the WG members through the agenda. The meeting was only accessible for participants in the UNGEGN Session.

ad 1) Opening, 2) Adoption of the Agenda

The Chair opened the meeting at 13.20 and welcomed the WG members. The meeting approved the draft agenda.

ad 3) Aims of the WG

The Chair referred briefly to the general aim of this WG to promote research on toponymy with a holistic approach, i.e. from the perspectives of all sciences engaged and relevant in onomastics. In detail the WG will aim at (1) proposing and organizing sessions on place names in the framework of relevant conferences and congresses; (2) organizing symposia on toponymy in cooperation with local host institutions; (3) developing, supporting and cooperating in toponymic research and book projects; (4) cultivating international cooperation with relevant global organizations like the International Cartographic Association (ICA) and the International Geographical Union (IGU) represented by the Joint ICA/IGU Commission on Toponymy, as well as the United Nations Group of Experts on Geographical Names (UNGEGN). The WG has a registered membership, an elected chair and an elected vice-chair. Its members are to be members of ICOS or will gradually assume ICOS membership.

ad 4) Membership

The Chair presented the list of 62 WG members from 33 countries and all continents as of 1 May 2025 by continents and countries (in English alphabetical order). He welcomed Sungjae Choo (Republic of Korea, UNGEGN Vice-Chair) and Awni Khasawneh (United Arab Emirates) as new members, who had applied for membership after the presentation of the ICOS report in the UNGEGN Session plenary. [After the business meeting also Osward Chanda Penda (South Africa) registered as a member raising the number of WG members to 63 from 33 countries.] The Chair introduced also Chrismi-

Rinda Loth from the University of the Free State (South Africa) as the elected Vice-Chair.

The **EuGeo Congress 2025 in Vienna [Wien]** on the theme "Geographies of a Changing Europe", 8-11 September 2025, will see 9 September 2025, 9.00-10.30 and 11.00-12.30, the Session "Place names between cultural heritage and cultural change" submitted on behalf of the WG and chaired by Peter Jordan. For this session 16 abstracts were submitted, but according to general regulations a maximum of 8 could be accepted.

Gabriel Moreno-Delgado (Spain): Cartographies of memory: street toponymy as a reflection of political regimes. Application to the case study of Elda (Spain)

Branimir Vukosav (Croatia): The changing narratives and identities in urbanonyms of Zadar, Croatia

Ivana Crljenko (Croatia): Building names motivated by commercial goals: A case study of Zagreb

Florian Koch, Laurent Gautier, Matthieu Llorca (all France): Stadium names between cultural heritage and commercialization: A quantitative study of four European countries

Donata Dorota Wysocka et al. (Poland): Specific dimension of functional integration - the naming of polycentric urban regions

Also the **32**nd International Cartographic Conference (ICC), Vancouver, Canada, "Mapping the future: innovation, inclusion, and sustainability", 16-22 August 2025, will see toponymic paper presentations, but with conferences of the International Cartographic Association (ICA) no session proposals can be submitted (e.g. by our WG), just abstracts for individual papers. They are only then thematically aggregated to sessions. The call for papers has already been closed and also peer-reviewing is completed. The **Eigth International Symposium on Place Names (ISPN) 2025, Clarens, South Africa** "Harmonising toponymic heritage: balancing standardisation and local diversity", 26-29 November 2025, is organized by the Department of South African Sign Language and Deaf Studies at the University of the Free State (RSA) in partnership with the Joint ICA/IGU Commission on Toponymy as well as the ICOS Working Group on Toponymy.

The call for papers has already been closed and the peer-reviewing is going on. Registration without paper presentation is still possible via kongresETFB@ufs.ac.za

ad 6) Proposals for activities

The Chair mentions two proposals already submitted and discussed in earlier meetings: (1) Florian Koch (France) proposed a symposium on names of stadiums that are usually landmarks with frequently changing and commercial names. Maciej Zych adds that the commercial part of the name is frequently only additional and indeed very fluctuant, while the core of the name remains relatively stable. (2) Joan Tort i Donada (Spain) proposed a symposium on the impact of river flow changes, especially in deltas, on the namescape. He presented the delta of River Llobregat near Barcelona as an example. Another example for comparison would be the former branches of the Danube [Donau] near Vienna, which, before the Danube's regulation in the second half of the 19th century, frequently had changed their course and left their traces in the namescape up to the present day. Kohei Watanabe adds that also the plain of Tokyo saw similar developments. Both proposals have remained ideas so far and are not near to realization.

Kohei Watanabe then, supported by other participants, develops the idea of tracing names after natural disasters or indicating dangerous places, e.g. vulcanism. Peter Jordan extends this idea to the impact of climate change on the namescape, e.g. the retreat of alpine glaciers.

ad 7) Other matters

Sungjae Choo wonders, whether the ICOS WG on Toponymy had a specific task, e.g. compared to the Joint ICA/IGU Commission on Toponymy. Peter Jordan hints at the WG's aim of approaching toponymy from a holistic perspective, i.e. from the perspectives of all onomastic sciences represented in ICOS, not the least linguistics, while the Joint ICA/IGU Commission on Toponymy is a joint venture of geographers and cartographers.

ad 8) Closure

The Chair closed the meeting at 14.30 and thanked all participants for attending.
